Actual Carry-over

In the Financial Proposal and Report, there is a carry - over of \$8876.00 to the 2022 - 2023 school year. This is 52 % of the distribution received in 2021 - 2022 of \$16935.00. Please describe the reason for a carry-over of more than 10 % of the distribution

The reason for the carry over is that the professional development allocation was much higher than anticipated. Plus, we only paid two teachers the IVC stipend. This year (2022/23), we do have more students taking classes via IVC; therefore, I still feel it is good to continue to fund this. However, the 21/22 school year we did not have the students register in the classes. We created an amendment to take place of our assemblies; however, that money was not spent as hoped. Therefore, we have a large carry over that we hope to spend this upcoming year to support two class periods of Art and Music. We have not had a qualified music teacher at our school for some time. The district was able to fund two hours this year for a music teacher, and we were able to hire a teacher. With this extra carry over money we will be able to hire this teacher for two more class periods.
